#### 4. Announcements

- 1.) Coordinating committee has been trained! They start immediately.
- 2.) AOP training at UVSS Board retreat
  - Last week, we thought that the AOP training that they are planning at the board retreat would cover one of the ones that they are required to do in policy throughout the year. This is not the case. This training is something the UVSS just does, the extra trainings that cover the ones in the policy will be done in the future and in consultation with us. So, the collective didn't go through with it's actions decided last week because of this new update.
- 3.) Advocacy Council
- There was an in-person vote regarding Pride's request for \$2000 for Tri's pro-d conference travel. The vote went through. The money will be put into Pride's account and cheque rec'd through Pride. Requests from the WC also went through. Advo council does not have a lot of money left.
- 4.) Garden Work Party
  - Garden work was well attended! Spent \$5 for soil.

## 5. Office Coordinator Contract Ending - Strike Hiring Committee

- Office Coordinator contract is ending at the beginning of June. We need to get the process to repost soon, if we want. If we want, we need to strike a hiring committee, with up to 3 collective members. One of them will be the chair of the committee. They will do the entire hiring process. Anybody interested in applying must recuse themselves from the hiring committee.

#### **DISCUSSION**

- Yeah! let's strike a hiring committee!
- Is there anybody who is interested in being on the hiring committee. Keep in mind that conflicts of interest (read out the hiring committee), must be noted during the hiring committee process, and members may be asked to recuse themselves if there is a conflict of interest.

# 6. Art-Series Workshop Proposal

 Collective member is proposing a workshop on video game glitching and to implement the glitches to make structural changes as an alegory of queer organizing and activism. This will be done on a computer, though requires some minor equipment.
Around \$10 for a controllor adaptor.

#### DISCUSSION

- Lux was asked to leave the room (facilitator that is proposed) while decisions and discussions continue.

- What about accessibility regarding video games? Motion sickness, turning cameras can be disorienting. Let's request that these be put in mind.
- Budget is total \$270, but ask the facilitator to aim lower on the the things.

- Washroom is too busy, nobody will see it.
- Contributing might appear like we mean money contributions. Could we say "monetary, or otherwise"?
- Or Contributing your time?
- Will it cost a lot if we put it onto the order forms?
- Maybe we should establish a working group to work on the blurb.

He has contacted Dale about what part of this trip is appropriate to cheque rec as part of the conference. Dale said the Vancouver - NY flight and the Toronto to Vic flight. As well as accomodations for April 30th, to May 2. However, the conference ends on May 3rd, and Tri is asking the collective to approve that he can cheque rec the night of May 3rd as well.
